All parts of the AHBV & AHGV Series are warranted to be free from defects for normal single family residential use for five years from the date of purchase by the original consumer for the original installation when installed per Heat Controller, Inc., installation instructions and in accordance with all local, state and national codes.

LIMITED SEVEN YEAR EXTENDED WARRANTY

The unit is warranted for an additional 7 years (total 12 years). All exceptions apply.

In addition, all parts are warranted for an additional seven years (for a total of 12 years) to the original consumer for the original installation, when the unit is installed with an ARI-matched condensing unit *PROVIDING* the unit is properly registered with Heat Controller within 90 days of the purchase either at www.heatcontroller.com or by mail. Without registration, the Warranty reverts to the **five year** parts warranty described above.

EXCEPTIONS
