This certificate is our warranty to you. Please insure that your installing dealer has completed the reverse side of this certificate.

COMPLETE UNIT WARHANTY

Except as noted in the Exclusions Section herein, the functional parts of air conditioning product(s) described on the reverse side of this certificate is (are) warranted against defects in material or workmanship under normal use and maintenance (a) for a period of five (5) years from the installation date or (b) for a period of sixty-three (63) months from ihe date of manufacture if the installation date cannot be verified. We will exchange any warranted defective part upon its' presentation to our distributor by a certified or licensed technician. We will exchange any warranted defective functional part or compressor that we furnished, upon presentation of said defective part to our distributor, by a certified or licensed technician.

Functional Parts are defined as: any part which if it failed would directly impact the operation or efficiency of the equipment.

EXTENDED PARTS WARRANTY

Applies to single phase units but not three phase units. In addition to the above Complete Unit Warranty, the following extended warranties apply as noted herein: An additional five year extended warranty for gas heat exchangers in Gas/Electric models PGB, PGJ, PGO, PGX, and PGH series packaged units only

EXCLUSIONS

THIS WARRANTY DOES NOT INCLUDE SERVICE OR LABOR CHARGES CONNECTED WITH DETERMINATION OR REPLACEMENT OF DEFECTIVE PARTS. ALL LABOR CHARGES ARE THE RESPONSIBILITY OF THE INSTALLING CONTRACTOR FOR THE LENGTH OF THE INSTALLER'S GUARANTEE, IF ANY, AND OUR WARRANTY THEREAFTER THE CONSUMER. OBLIGATION IS LIMITED TO THE EXCHANGE OF DEFECTIVE ITEMS AS SPECIFICALLY PROVIDED HEREIN. WE WILL NOT PROVIDE ANY OTHER FORM OF COMPENSATION IN LIEU OF THIS EXCHANGE PROVISION.

warranty programs 10 unginai rurcnaser: I nese programs are offered to the original end purchaser for Goodman produced 1 through 5 ton single phase units only and are not transferable to subsequent buyers of the property. These programs are offered for the Continental United States and Canada only. Registration form and proof of installation (documents 1 or 2) and check must be submitted within 60 days of installation.

PROGRAM A

Second Through Fifth Year Compressor Labor Allowance Program

This program covers up to a S400.00 labor reimbursement for compressor replacement during the 13¹" through 60th month following installation on applicable Goodman product, but does not cover handling and transportation costs associated with replacement of the failed compressor.

PROGRAM B

Sixth Through Tenth Year Compressor Exchange Only Program Duration of the warranty is from the first day of the 615t month to the last day of the 120^{lh} month following installation, in case of a failure, Goodman will reimburse you for the cost of the Goodman replacement compressor only The warranty period for the replacement compressor will last only for the remainder of the warranty period of the compressor exchange warranty program. Wore: Goodman produced high-efficiency (12 SEER and above) air conditioners and heat pumps installed after August 1, 1995 include a standard factory parts only warranty through the tenth year on the compressor, therefore the purchase of Program B is not necessary on those products.

PROGRAM C

Second Through Tenth Year Compressor Labor Allowance And Sixth Through Tenth Year Compressor Replacement Program This program covers both the 2nd through 10^{lh} year up to a \$400.00 labor reimbursement for compressor replacement and reimbursement for the cost of a Goodman replacement compressor, but does not cover handling or transportation costs associated with replacement of the failed compressor.

Note: Goodman produced high-efficiency (12 SEER and above) air conditioners and heat pumps installed after August 1, 1995 include a standard factory parts only warranty through the tenth year on the compressor, therefore you should purchase Program D for those products.

PROGRAM D

Second Through Tenth Year Compressor Labor Allowance

This program covers up to a \$400.00 labor reimbursement for compressor replacement during the 13th through 120w month following installation on applicable Goodman product, but does not cover handling and transportation costs associated with replacement of the failed compressor.

- Products installed outside the United States or Canada.
